Proxy ballots and a roster of candidates will be distributed to General Members on January 12, 2024, so that General Members who cannot attend the Annual Meeting may vote. Completed proxy ballots must be received by SABA-GA **5:00 P.M. EST on Thursday, January 18, 2024**. Election results will be announced to General Members at the Annual Meeting, following voting.
